A Resolution  
of  
The United Pipe Clubs of America  
Tobacco Blends for Smoking Contests

WHEREAS, the United States is fortunate to have many custom blenders of excellent

WHEREAS the United Pipe Clubs of America desires to promote the wares of American custom blenders, and

WHEREAS CIPC rules specify that we must announce the blend to be used in a National, Regional, or local contest

BE IT RESOLVED that the Board of the United Pipe Clubs of America has the authority to invite a blender to furnish the tobacco for the Annual National Pipe Smoking Championship, PROVIDED the blender will make up enough tobacco to provide at least one practice smoke on the day preceding the competition.

BE IT FURTHER RESOLVED that the Board of the United Pipe Clubs of America encourages its member clubs to use this process in their selection of the blends for smoking contests.
